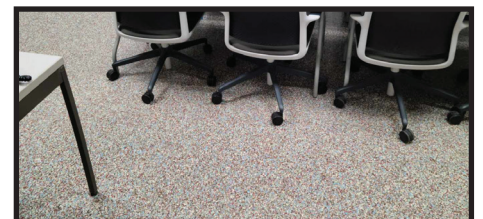
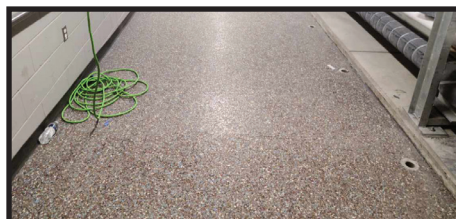
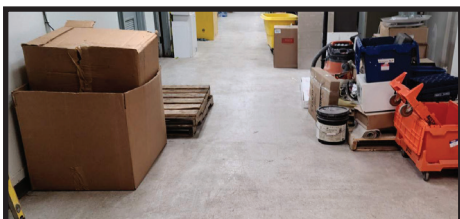


In the above photos, this Service Centers floor had PCB contamination from transformer oil spilling on it. They not only needed to clean up the visible transformer oil leakage, but would need to have a solution that would end with the PCBs being encapsulated if the facility was still to be used. It would have cost the client millions of dollars to dig the floor and ground out to get rid of the PCB contamination. Instead, Unconventional Solutions, Inc. offered a solution at a fraction of that cost. To encapsulate the PCB the USI Team suggested using USI Flexible Broadcast Primer, along with 2 coats of USI Self Leveling Epoxy Slurry. The first coat of the Slurry goes on in red. The second coat of Slurry goes on in gray. This two color process is on purpose. This way, if any parts of the floor start to show red in color, the Service Center knows it is time to contact USI for another coat of the Slurry to keep the PCBs encapsulated, and the working environment safe.
